1. **Loftus PULLIN**¹⁻⁵ was born about 1720.⁶⁻⁷ Property: 240 acres conveyed Loftus by James Patton and Lewis in Calfpasture River area, Augusta County, VA on 17 Jul 1745.⁸ Location: Bullpasture, 1 mile above Clover Creek in 1746.⁹ Location: in Cowpasture River Valley, Highland County, VA lived there when the first surveyors laid out tracts in 1746.¹⁰ Location: in Bullpasture River Valley, Highland County, VA Among the earliest settlers in the Bullpasture Valley, Highland County about 1750.¹¹ Individual Note: in 1751 Appointed by the court to help clear a road from Estill's mill to the head of the Calfpasture.¹² Individual Note: in 1753 Worked on a road from Estill's mill to William Wilson's mill on Bolar Run.¹³ Individual Note: in 1754 in Augusta County, VA Signed a petition condemning the selling by ordinaries of large quantities of liquor at extravagant rates, whereby money is drained out of the county. Petition signers intended to make their own liquor so as to keep the money in the home neighborhood.¹⁴ Individual Note: in 1757 in Bullpasture River Valley, Augusta County, VA assisted in the building of Fort George on land of Wallace Estill.¹⁵ Location: in Cowpasture Valley, VA in 1758.¹⁶ Property: Land 4 miles south of McDowell, VA was from original grant in 1743 then further granted in 1758.¹⁷ Property: sold 240 acres on the Calfpasture River to James Shaw for five shillings in Augusta County, VA on 19 Aug 1760.⁸ Property: 55 acres in Bullpasture River Valley, Augusta County, VA on 11 Nov 1762.¹⁸ Individual Note: on 13 Apr 1778 in Augusta County, VA signer of a petition to establish a new county.¹⁹ Military: on 15 Feb 1780 allowed certificate for land for military services in Augusta County, VA.²⁰ Property: 400 acres surveyed joining his home tract on the Crab Run in Bullpasture River Valley, Augusta County, VA on 28 Mar 1782.²¹ Property: 400 acres patented joining his home tract on Crab Run in Bullpasture River Valley, Augusta County, VA on 14 Jun 1783.⁴ Family Note: about 1785 indentured servant from England, Joseph Carpenter, lived about seven years with family in Augusta County, VA.²² Property: owns 13 horses and 30 cattle in Augusta County, VA in 1787.²³ Property: 1 white male 16-21, 2 blacks over 16, 2 blacks under 16 in 1787.²³ Property: deeded 300 acres on Crab Run to son John; portion of 400 acres patented previously to Loftus in Bath County, VA on 7 Apr 1800.²¹ He signed a will on 2 May 1801 in Bath County, VA.²⁴ He died in 1801; at the age of 81.²⁵⁻²⁶ Estate: on 3 Feb 1802 in Bath County, VA inventory: 21 hogs, 19 sheep, 28 cattle, 7 horses, 2 stills, Bible, 10 slaves, and several other items.²⁷ Estate: Left personal property of \$522.32.⁶ Military: Fought in the French-Indian and Revolutionary Wars.²⁸

Loftus PULLIN and Ann Jenny "Nancy" USHER²⁹ were married about 1750.³⁰⁻³² **Ann Jenny "Nancy" USHER**³²⁻³⁸, daughter of Edward USHER and PERRY, was born about 1731.¹⁵ Family Note: on 11 Feb 1745 James Knox became her guardian in Augusta County, VA.³⁹⁻⁴⁰ Location: in Bullpasture River Valley area of Bath County, VA in 1805.⁴¹ She died in 1805; at the age of 74 in Bath County, VA.⁴² She signed a will on 16 Sep 1805 in Bath County, VA.⁴¹ Estate: on 10 Nov 1805 in Bath County, VA inventory: 8 sheep, 45 cattle, 4 horses, 18 pigs, Negro girl and her child, and other items.⁴³
